Vendor Information & Rules:

This event is a festival, and it is not based on one band, act, or feature. all features, bands, acts, performances, and elements are subject to change without notice. This is a rain or shine event with no refunds.

In the case of promoter elected complete event cancelation, vendors' space rental fees and/ or sponsorship monies will be refunded within 30 days from cancelation.

Promoter is not responsible to provide refunds in the case of acts or war, terror, acts of God, political events, legal or social demonstrations, or any event or incident outside the control of the promoter.

Further, the promoter is not responsible for any other loss occurring from the cancelation. all spaces will be assigned and agreed upon by both parties in advance. no changes shall be made, or locations occupied by a vendor without prior permission. IF YOU NEED A TENT - YOU MUST HAHVE A FIRE RATED POP UP TENT/S WITH WEITGHTS AND TIEDOWNS Vendor must be ready to operate at the time of gates opening as agreed upon.

No vendor shall break down or remove their products, tents or set up before the close of business on any day of the festival. should a vendor need to leave due to an emergency. they must inform the staff and have staff and security escort to aid in the public safety. Vendors will operate within the agreed upon parameters and will not vendor or sell any product or provide any service not detailed in this agreement.

No vendor shall sell or carry any weapons, firearms, dangerous or hazardous materials - this includes open carry permit holders. No vendor may bring any outside alcohol or illegal substances into the stadium. Controlled prescription substances are the exception. This is a non-smoking stadium. vendors must leave the stadium and smoke in designated smoking areas in the parking lots.

We ask that all vendors refrain from alcohol consumption while serving the guest. and please do not drink in your space. vendors are responsible for safeguarding their products, property, and equipment at all times.

Vendor will be responsible for the actions of their staff at all times while on festival and stadium property and conduct themselves in a business- like manner at all times in dealing with staff, security, law enforcement and the general public.

You are responsible for your vendor passes. And agree to only issue them to staff working your booth. You may not sell or lend them to anyone to gain access to the event without a ticket. You have been provided GA tickets to offer guests. Vendors passes are solely for those working your booth and they must keep them on their person at all times in the stadium.

No vendors may enter the bands locker rooms or attempt to interact with band members while on property other than those means provided by band management.

No vendor shall enter any restricted areas.

Should the vendor use any moving equipment, hand trucks, or carts that may be borrowed from the promoter to aid in vendor move in or out, it is at the sole risk of the vendor. The promoter shall be held harmless for any accidents, damage, or injury that may occur from the use of this equipment.

Should an emergency arise that a vendor or their staff is asked to leave the stadium, please do so in an orderly manner and follow the instructions of stadium security, staff, or law enforcement.

Any violation of these rule can be grounds for ejection from the event without refund.
